"RESOLVED THAT pursuant to the provisions of Sections 13, 61(1) read with Section 64 and other applicable provisions, if any, of the Companies Act, 2013 and the relevant rules framed thereunder (including any re-enactment(s) and statutory modification(s) made there under, if any, for the time being in force) and in accordance with the applicable provisions of the Articles of Association of the Company, such other statutes, laws, rules, regulations, guidelines, circulars, directions, notifications and clarifications as applicable from time to time, consent of the Shareholders, be and is hereby accorded to increase the authorized share capital of the Company from Rs. 114,00,000/(Rupees One Hundred and Fourteen Crore) divided into 11,40,00,000 (Eleven Crore Forty Lakh) Equity Shares of Rs. 10/- (Rupees Ten) each to Rs. 123,00,00,000/- (Rupees One Hundred and Twenty Three Crore) divided into 12,30,00,000 (Twelve Crore Thirty Lakh) Equity Shares of Rs. 10/- (Rupees Ten) each by creation of additional 90,00,000/- (Ninety Lakh) Equity Shares of Rs. 10/- (Rupees Ten) each ranking pari passu in all respects with the existing Equity Shares of the Company.

RESOLVED FURTHER THAT the existing Clause V of the Memorandum of Association of the Company be and is hereby altered by substitution of the following new clause as Clause V:

V. The Authorised Share Capital of the Company is Rs. 123,00,00,000/- (Rupees One Hundred and Twenty Three Crore) divided into 12,30,00,000 (Twelve Crore Thirty Lakh Equity Shares of Rs. 10/- (Rupees Ten) each.

RESOLVED FURTHER THAT the Board of Directors be and are hereby severally authorized to undertake all such acts, deeds, matters and things to finalize and execute and file all papers, forms, acts, deeds, matters and things such as may be deemed proper, desirable and expedient in its absolute discretion, such as may be deemed necessary (including but not limited to filing(s) with Registrar of Companies, NCT of Delhi & Haryana and other statutory/regulatory authorities), to enable this resolution and to settle any question, difficulty or doubt that may arise in this regard.

RESOLVED FURTHER THAT a certified copy of this Resolution be provided to all concerned as and when required under the hand of a Director or Company Secretary of the Company."



EXPLANATORY STATEMENTS PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013

ITEM NO. 1:

In order to meet the additional requirements of funds, the Company intends to expand its present business activities. For this purpose, the authorized share capital at present is Rs. 114,00,00,000/- (Rupees One Hundred Seven Crore) divided into 11,40,00,000 (Eleven Crore Forty Lakh) Equity Shares of Rs. 10/- (Rupees Ten) each.

In view of the proposed Right Issue, the existing authorized share capital needs to be increased from Rs. 114 Crore to Rs. 123 Crore by addition of 90,00,000 equity shares of Rs. 10 each.

Consequent to the increase of authorised share capital, the authorised share capital clause contained in Clause V of the Memorandum of Association of the Company need to be altered as indicated in the resolution No. 1 above.

The Board recommends the above resolution for your approval by way of Ordinary resolution.
