

Disclosure on Liquidity Risk as on 30st June 2025

RBI has issued guidelines on Liquidity Risk Management Framework for Non-Banking Financial Companies including Housing Finance Companies. As per the guidelines, the disclosure on liquidity risk as at June 30, 2025 is as under:
